E. On the real test you will not have time to read every word. You need to practice scanning and reading quickly for details.

F. Assist student on how to do scanning and how to read quickly

G. Manage time wisely in this part of the test.



A new ruling which came into effect last week requires some homeowners to purchase new smoke alarms. The ordinance states that there should be a fire alarm installed in every bedroom of the house, and these alarms must comply with certain safety standards. Some local residents are displeased at these new regulations. This week Merrymaker Cruise lines has filed a \$700 million lawsuit against Wambaugh Marine Industries, a shipyard that filed for bankruptcy last November before completing a three-ship contract for Merrymaker.
