In Part VII you will read passages in the form of letters, ads, memos, faxes, schedules, etc. The reading section has a number of single passages and 4 double passages. You will be asked 2-4 questions about each single passage, and 5 questions for each double passage. Sometimes you will be asked for specific

details. Other times you will be asked about what the passage implies. In the paired passages you will also be asked to make connections between the two related texts. On the real test you will not have time to read every word. You need to practice scanning and reading quickly for details.

#### **Customs Documentation for International Mail**

International mail is subject to customs examination in the destination country, and the contents and value must be declared on special forms. **Letter Packages, Small Packets, and Dutiable Printed Matter** Letter packages containing dutiable printed matter, all small packets, and dutiable printed matter must have one of these forms attached:

- Form 2976, Customs Declaration C-1 (green label)
- Form 2976-A, Customs Declaration C-2 (adhesive white declaration form)

If the value of the contents exceeds \$400, Form 2976 must be completed and enclosed in the package and the upper adhesive part of the label is to be affixed to the outside wrapper. If the value is under \$400, Form 2976-A may be attached to the wrapper.

### **Parcel Post**

All parcel post items (surface or air) mailed to a foreign country must have one of these forms attached

- Form 2966-B, Parcel Post Customs Declaration and Dispatch Note (a three part document).
- Form 2966-E, (clear plastic envelope) is for use only with form 2966-B.

Consult your post office for individual country requirements.
